Gordy Blum discussed the five timber sales Blackduck is offering. Gordy also spoke about an appeal that the Continental Divide received.

Greg VanOrsow discussed the budget issues and that extensions have been added to about 95% of their timber sales. Greg also discussed the Forest Leadership Team coming to visit the area in October 2009.

Greg Morris informed the committee that a decision notice was put out on the Upper East Winnie Project. Greg also reviewed a list of funded stimulus projects. The complete list will be listed in the Forestry article he wrote for the Chamber's newsletter. Greg then spoke about an appeal that was received regarding the Enbridge Project and that Congressman Oberstar will be attending the Grand Opening Celebration at the Minnesota Discovery Center on September 3, 2009.

Terry Weber informed the committee that the Forest History Center will be focusing on education opportunities now that the tourism season is coming to an end. Terry also discussed the bow hunt that will be taking place at the Forest History Center.

Dale Sutherland reported that he has been focusing on invasive species.

Bud informed the committee that he will be Washington, DC September 21-23, 2009 and discussed a possible pellet business that may be going into part of the Ainsworth building.

Julie Miedtke spoke about a Woody Biomass Workshop that Extension will be offering in September; as well, as some workshops for women that the extension is able to provide due to a Federal grant they received. The workshops are titled "Kitchen Table Gatherings." Julie also informed the committee that Extension Store is offering a new book for sale titled, "Woodland Stewardship."

Paul Peterson discussed a new hire who will be working on filling the "hole" in the market created by wood based businesses closing.

Kim Hanson discussed the MN Deer Hunters Banquet that is coming up.

Criag Engwall informed the committee that Bob Schroeder resigned from the LOHC, leaving an opening that will need to be filled by the Governor.
