## Vendors:

### **YOU MUST FILL OUT & RETURN THE ST-19 FORM OR VENDOR WITHOUT TAX ID FORM WITH YOUR REGISTRATION FORM.**

1. To be pre-registered your money, registration form and ST-19 must be received by May 15<sup>th</sup>.
2. Vendors **must** be **pre-registered**, to hold the same spaces they had last year.
3. The spaces will be marked with your name and may be in a slightly different location due to fairgrounds remodeling.
4. **THERE WILL BE NO EARLY SET UPS. TO AVOID CONGESTION ~ PLEASE DO NOT ARRIVE BEFORE THE DESIGNATED SET UP TIME FOR YOUR LOCATION.**  
Gates will open for set up Friday at 8:00 a.m. for indoor vendors and 12:00 noon for outdoor vendors. Vendors not pre-registered will be allowed to set up after the pre-registered vendors.
5. Registration fees:  
**Outside vendors:** Registrations received by May 15<sup>th</sup> are \$35/space. Registrations received after May 15<sup>th</sup> are \$45/space. Spaces are **approximately** 10 X 30.  
**Inside vendors:** Registrations received by May 15<sup>th</sup> are \$45/space. Registrations received after May 15<sup>th</sup> are \$55/space.  
Spaces are **approximately** 10 X 12. All spaces are dependent upon availability.  
**All vendors:** Your parking pass must be hung on your inside rearview mirror to enter the Fairgrounds. This tag will allow free parking and let everyone know you are pre-registered.
6. Vendors are responsible for all damages. Please carry your own liability insurance.
7. You will receive a confirmation notice by mail or email (if available) as we receive your payment and registration. Please contact the Grand Rapids Area Chamber at (218) 326-6619 if you do not receive a confirmation by June 15<sup>th</sup>.
8. Please send payment in for VENDOR SPACES ONLY. We **do not** collect camping fees. Camping on your vendor space is allowed after set up only. Make sure you have room to open doors etc...
9. We will hold pre-registered spaces until SATURDAY at noon, unless we are notified ahead of time that you will be arriving after noon on Saturday. *Refunds available if cancellation is received by July 23, 2019.*
10. **FAIRBOARD POLICY: No dogs allowed except service animals.**  
**No golf carts, ATVs or side by sides.**
11. **Vendor stock must consist of auto-related items, antiques and collectibles, personally handcrafted items and art items ONLY. No used clothing or rummage sale items allowed. NO SALE OF FOOD ITEMS ALLOWED. (Except for booths staffed by the Grand Rapids Area Chamber of Commerce or its authorized agents). Approved item questions/concerns can be directed to Bud Stone at (218) 326-6619.**
12. Any ATV's, motorcycles, scooters, bikes, skateboards or roller blades that are for sale need to be kept in vendor spots and may not be ridden during the event.

If you are not pre-registered, you will need to fill out a Vendor Registration form and an ST-19 form at the Trailhead building. You will then be assigned a vendor spot after pre-registered vendors are set up.
