Important Workplace Law Changes for the New Year

As we usher in the new year, businesses and workers in Minnesota should be aware of significant changes on the horizon. The Minnesota Department of Labor and Industry is implementing several laws beginning January 1, 2024.

These changes cover a range of areas. It's crucial for employers and employees alike to familiarize themselves with these updates to ensure compliance and foster a positive and equitable work environment. Here are some highlights from the most recent workplace and wage bulletin from the Minnesota Department of Labor and Industry.

Workplace law updates for the new year

Earned sick and safe time

Minnesota's earned sick and safe time (ESST) law goes into effect Jan. 1, 2024. The Department of Labor and Industry (DLI) continues to add resources and materials to help employers comply with the new law. Resources recently added include:

- New ESST FAQs.
- A recorded webinar presentation.
- An outreach toolkit for organizations and individuals who would like to help build awareness about the ESST law.
- A sample employee notice in 18 languages. Employers must provide an ESST notice to employees upon the start of their employment or by Jan. 1, 2024, when the ESST law goes into effect, whichever date is later. This notice needs to be provided to employees in English and the primary language of the employee if not English.
- An ESST workplace poster in 18 languages.

Minimum-wage rate

Effective Jan. 1, 2024, Minnesota's minimum-wage rates will increase from \$10.59 to \$10.85 an hour for large employers and from \$8.63 to \$8.85 an hour for other state minimum wages.

Pay-history ban effective Jan. 1, 2024

Employers in Minnesota may no longer ask a job applicant about their pay history beginning Jan. 1, 2024. This law is being implemented, overseen and enforced by the Minnesota Department of Human Rights.
